- (2) The firms / individuals who are willing to submit the quotation must have minimum of three years of experience in the similar nature of work.
- (3) Quotation should be submitted in sealed cover and superscribed with the **Name of the work with NIQ No.**
- (4) Quotations will be received in the office of the undersigned in hard copy only. No quotation will be entertained if sent by Post / Courier.
- (5) The Quotationer must sign each page of the quotation paper, relevant documents etc. which form part and parcel of the quotation document.
- (6) Conditional quotation will not be entertained and shall be deemed as "informal".
- (7) Quotation documents are not transferable.
- (8) Any quotation without Earnest Money Deposit (EMD) shall be rejected by BSRDCL and shall be treated as non-responsive.
- (9) The Rates shall be quoted by quotationers in English only.
- (10) In case of any discrepancy of amount quoted in figures & words, the amount quoted in words will prevail.
- (11) BSRDCL shall make the payment of work after deducting the taxes applicable.
- (12) The Quotations will be opened in the presence of Quotationers or their authorized representatives who may be present at the time of opening if they so desire.
- (13) Successful Quotationer has to submit Non-Judicial Stamp of Rs. 1,000/- for agreement after issuing work order with Performance Security amount as required.
- (14) The EMD of unsuccessful quotationers will be returned. In case of successful quotationer the same shall be retained as Performance Security. The EMD / Performance Security of successful quotationer will be released within three months after successful completion of work / contract.
