<b>ITB 19.1</b>	<p><b>A Bid Security shall be required, not A Bid Security declaration.</b></p> <p>The amount and currency of the bid security shall be <b>INR 25.75 Million or an equivalent amount in a freely convertible currency.</b></p> <p><b>The Exchange rate to be used in conversion of the Bid Security amount in a freely convertible currency shall be the selling Exchange Rate published by the Reserve Bank of India on the Date 28 days prior to the date for the deadline for Bid Submission (excluding the date of Submission).</b></p>

<b>ITB 19.3</b>	A Bid Security issued by reputable Banks located outside the Employer’s Country, or reputable local Banks, including scheduled Banks or Nationalized Banks, in the form of an unconditional Bank Guarantee shall be accepted. In case the bidder submits a Bank Guarantee issued by a foreign Bank from an ADB member Country, the Bank must have a corresponding Bank in India which in turn must issue a counter guarantee on the guarantee issued by the foreign branch to make it enforceable. Employer reserves the right to verify BG.
<b>ITB 19.4</b>	Subject to the succeeding sentences, any bid not accompanied by an irrevocable and callable bid security shall be rejected by the Employer as nonresponsive. If a Bidder submits a bid security that (i) deviates in form, amount, and/or period of validity, or (ii) does not provide sufficient identification of the Bidder (including, without limitation, failure to indicate the name of the Joint Venture or, where the Joint Venture has not yet been constituted, the names of all future Joint Venture Partners), the Employer shall request the Bidder to submit a compliant bid security within 14 days of receiving such a request. Failure to provide a compliant bid security within the prescribed period of receiving such a request shall cause the rejection of the Bid.

However, the soft copy of BOQ shall not form part of the bid.
