- The interested consultancy firms shall also have to comply the requirement of registration, if applicable as per office memorandum no. F.No. 6/18/2019-PPD dated 23rd July, 2020 issued by Public Procurement Division, Deptt. of Expenditure, Ministry of Finance, Govt. of India, are only eligible.
- The Applicant shall furnish as part of its Proposal, a Proposal Security in the favour of Chief General Manager, Bihar State Road Development Corporation Ltd., Patna for an amount of Rs.2,00,000.00 (Two Lakh Only) through online payment gateway / Bank Guarantee from any Nationalized Bank and shall remain valid till 28 days beyond the Proposal validity period of 90 days. Proposal Security in Original form will have to be deposited in the office of Chief General Manager, Bihar State Road Development Corporation Ltd., Patna on or before 12:00 Hrs on date specified above and mentioned in Data Sheet, failing which the Proposal will be rejected.
- E-tendering processing fee, as applicable shall be paid online to BELTRON at the time of uploading of RFP.
- For participating in E-RFP process, the applicant shall have to get them registered to get user ID Password and digital Signature. - All the uploaded documents shall have the signature of Consultants or their authorized signatories. The scanned copies should be of the original papers and certificates.
- Consultants will have to declare by affidavit that they have not been declared defaulter or blacklisted or debarred by any State Government/Central Government/Public Undertaking, if such an affidavit is subsequently found to be false, their proposal shall not be considered and further legal action may be initiated.
- The Consultant is requested to check their file size of uploaded documents at the time of submission & they should ensure that work file is uploaded if they feel that the complete file is not uploaded then they should click on cancel & update the same before submission. The Consultant

- should satisfy themselves of Download ability and visibility of the scanned & uploaded file by them.
