- The Government of India (hereinafter called "Borrower") has applied for financing from Asian Development Bank toward the cost of **Additional Financing for Enhancing Connectivity and Sustainability in Bihar Road Project (formerly Bihar State Highway-IV (Phase-1) Project)**. Part of this loan will be used for payments under the contracts named above. Bidding is open to Bidders from eligible source countries of ADB.
- Bihar State Road Development Corporation Limited (BSRDCL)**, a Government of Bihar Undertaking, the Executing Agency, ("the Employer") invites electronic bids from eligible bidders through **Eproc-2 website i.e. <https://eproc2.bihar.gov.in>** for the Construction and completion of Improvement / Upgradation and strengthening of the following civil works contract packages under the Project, subject to compliance with ADB policies and requirements. The project roads comprise civil works under the following contract packages:

- Open Competitive bidding- National Advertisement** will be conducted in accordance with ADB's **Single-Stage: Two-Envelope** bidding procedure as per ADB Procurement Policy (2022, as amended from time to time) and Procurement Regulations for ADB Borrowers (2022, as

amended from time to time) and is open to all bidders from eligible source countries as described in the Bidding Document.

4. Bidders may bid for one or several contracts, as further defined in the bidding document. Bidders wishing to offer discounts in case they are awarded more than one contract will be allowed to do so provided those discounts are included in the Letter of Bid.
5. The following qualification criteria are disclosed to enable potential Bidders to make an informed decision whether to pursue the contract either as a single entity or in joint venture (JV). Qualification Criteria in brief are as under:

- A. **Financial Performance:** The Bidder should submit audited balance sheets for the last three (3) completed financial years (FY 2021-22, 2022-23, and 2023-24). For JV, the balance sheet for each constituent entity should be submitted.
- B. **Net worth:** As a minimum, the Bidder's net worth for each of the last three (3) completed financial years (FY 2021-22, 2022-23, and 2023-24) calculated as the difference between total assets and total liabilities should be positive. The single entity or each partner must meet the requirement.
- C. **Average annual Construction Turnover:** Minimum average annual construction turnover based on certified payment received for contracts in progress or completed over the last three (3) completed financial years (FY 2021-22, 2022-23, and 2023-24) should not be less than as mentioned above in above table. The single entity or all partners combined must meet the requirement. In case of JV, each partner must meet minimum 25% and one partner minimum 50% of this requirement.
- D. **Financial Resources:** The minimum amount of Financial Resources available should not be less than as mentioned above in above table. The single entity or all partners combined must meet the requirement. In case of JV, each partner must meet minimum 25% and one partner minimum 40% of this requirement.
- E. **Construction Experience:** Bidder must have experience of having successfully or substantially completed similar nature of works during the last five (5) years (reckoned from 28 days before the last date of bid submission) for any of the following:

- The single entity or all partners combined must meet the requirement. In case of JV, each partner must meet minimum 25% and one partner minimum 50% of this requirement.

- (a) Cost of Bid Document for the single project is **Rs. 25,000.00 (Rupee Twenty Five Thousand only)** shall be paid online through online payment gateway.
(b) Bid Security shall be in favour of **Bihar State Road Development Corporation Ltd.** in the form of a bank Guarantee issued by Nationalized Bank or a scheduled Bank in India in the Requisite format of Bid Document and having a validity period of not less than **180+28 days** from the bid due date.
- E-tendering processing fee, as applicable shall be paid online at the time of uploading the bid.
- For participating in E-Bid process, the applicant shall have to get them registered to get user ID Password and digital Signature. This will enable them to access the website- **www.eproc2.bihar.gov.in** and download/participate in e-tender. Those who are not registered in e-tendering systems, they may contact "e-procurement-2 HELPDESK, Address: - M Junction Services Limited, RJ Complex, 2nd Floor, opposite of Vidyapeeth institute, Khajpura, Ashiana Road, P.S.- Shastri Nagar, Patna 800014, Bihar" (Toll Free No.-18005726571) for registration. The website also has user A manuals with detailed guidelines on enrolment and participation in online bidding.
- Bidders can access Bid documents on the website, fill them out and submit the completed Bid document Electronically through the website. Bidders shall attach

scanned copies (PDF) of all the required Bidding papers, i.e. Bank Draft and the certificates as required in Eligibility criteria.

11. All the uploaded documents must have the signature of the bidder or their authorized signatories. The scanned copies should be of the original papers and certificates.
12. Bidders are requested to check their file size of uploaded documents at the time of submission. They should ensure that the entire file has been uploaded. If they believe that the complete file is not uploaded, they should click on 'Cancel' and update the file before submission. Bidders should ensure that the scanned and uploaded file are visible and downloadable.
13. The bidder is directed to zip their files using Win Zip or Win RAR software only. Other compression format will not be accepted and will be rejected.
14. No claim shall be entertained on account of disruption of internet service being used by bidders. Bidders are advised to upload their bids well in advance to avoid last minute submission.
15. Corrigendum/Addendum/Corrections/Authority Response to the queries at pre bid meeting, if any, will be published on the e-proc2 website as well as on the BSRDC Ltd website- <http://bsrdcl.bihar.gov.in>
16. The BSRDC Ltd. reserves the right to extend/cancel the tender (RFP) at any stage without assigning any reason thereof.
17. A pre-bid meeting will be held at the Office of the Chief General Manager at the address indicated above on **26 June 2025 at 03:00 PM (IST)**.
18. Bid must be submitted online only through e-procurement portal www.eproc2.bihar.gov.in using the digital signature of authorised representative of the Bidder on or before **15 July 2025 (upto 3:00 PM IST)**.
19. The Bidder shall submit the required documents (Stated in ITB 21.1 (b) item no. 2.4) physically at the address specified in bid document on or before **16 July 2025 (upto 12:30 PM IST)**.
20. The Technical Bids shall be opened through E-proc2 website on **15 July 2025 at 03:30 PM (IST)**, in the presence of the authorized representatives of the Bidders, who choose to attend. Technical Bid of any bidder whose documents listed in the RFP have been physically received after the date and time mentioned in the IFB shall be rejected.
21. The Financial Bids of only technically Responsive bids shall be opened electronically after Technical Bid Evaluation.
