INVITATION FOR BID ON HYBRID ANNUITY MODE

Invitation for Bids for:-

"Extension of J.P. Ganga Path Project from Digha – Sherpur - Koilwar Road on Hybrid Annuity Mode"

The Bihar State Road Development Corporation Limited (BSRDC Ltd.) is desirous for **"Extension of J.P. Ganga Path Project from Digha – Sherpur - Koilwar Road on Hybrid Annuity Mode"**

1. BSRDC Ltd. intends to undertake a single stage two bid system open competitive bidding process in order to shortlist and qualify successful bidder at the qualification stage, who shall be eligible for evaluation of the price bid of the successful bidder in terms of the RFP, for awards of the project.
2. The successful Bidder at the end of the Bidding process may be awarded a contract by BSRDC Ltd. to implement the project on Hybrid Annuity Mode. The concessionaire (SPV formed by successful Bidder) shall be responsible for the Design, Finance, Engineering, Procurement, Construction and Maintenance for 15 years of the project in terms of the Agreement to be signed between the Concessionaire and BSRDC Ltd. Further, the Concessionaire shall be responsible for remedying all defects and deficiencies, normal wear and tear expected, in the project or any section thereof during the defects liability period/Maintenance period in terms of the concession agreement to be executed in terms of the RFP.
3. The details of the bidding process and summary of the scope of project work are included in the RFP document.

(a) Form fee (Cost of Bid Document) for the project under Para 7 of Rs. 6,60,800.00 (Rupee Six Lacs Sixty Thousands Eight Hundreds only) for work specified shall be paid **online through online payment gateway**. The complete document can be review/downloaded from <https://eproc2.bihar.gov.in> and can also be reviews on official portal of BSRDCL.
(b) Bid Security shall be in favour of **Bihar State Road Development Corporation Ltd.** in the form of a bank Guarantee issued by Nationalized Bank or a scheduled Bank in India in the format at Appendix-II of Bid Document and having a validity period of not less than 120+60 days from the bid due date.
7. E-tendering processing fee, as applicable shall be paid online at the time of uploading the bid.
8. The interested contracting firms shall also have to comply the requirement of registration, if applicable as per office memorandum no. F.No.6/18/2019-PPD dated 23rd July, 2020 issued by Public Procurement Division, Dept. of Expenditure, Ministry of finance, Govt. of India, are only eligible.
9. For participating in E-Bid process, the applicant shall have to get them registered to get user ID Password and digital Signature. This will enable them to access the website- www.eproc2.bihar.gov.in and download/participate in e-tender. 11. Bidders can access Bid documents on the website, fill them and submit the completed Bid document into Electronic Bid on the website itself. Bidders shall attach scanned copies (PDF, JPG) of all the required Bidding papers, i.e. Bank Draft & the certificates as required in Eligibility criteria.
12. All the uploaded documents must have the signature of the bidder or their authorized signatories. The scanned copies should be of the original papers and certificates.
13. The bidder is requested to check their file size of uploaded documents at the time of submission & they should ensure that work file is uploaded if they feel that the complete file is not uploaded then they should click on cancel & update the same before submission. The bidders should satisfy themselves of download ability, visibility of the scanned & uploaded file by them.
14. The bidder is directed to zip their files using Win Zip or Win RAR software only. Other formats of zipping will not be accepted and will be rejected.
15. No claim shall be entertained on account of disruption of internet service being used by bidders. Bidders are advised to upload their bids well in advance to avoid last minute submission.
