12. Any Contractor registered with the Central Government / any State Government or any PSU or an agency of international or national repute may participate in the tender but registration with the Road Construction Department, Bihar will be essential after issue of Letter of Acceptance and before executing the agreement.

14. For participating in the above e-tendering process, the bidder shall have to get themselves registered with the service provider so that user ID, password and Digital Signature are issued to them. This will enable them to access the website www.eproc2.bihar.gov.in and download/participate in e-Tender. 15. The undersigned reserves the right to extend or cancel or reject the tender/tenders at any time without assigning any reason thereof. No cost whatsoever shall be claimed on such account by the bidder.

17. Earnest money (Column-4 of clause 8) EMD can be only in the form of **Bank Guarantee**, (B.G.) as duly endorsed to the **Chief General Manager, BSRDCL**.

The above B.G. shall be issued on/after the start of uploading of bid documents by the employer and before/up to the stipulated last date of uploading the bid by the bidder, shall be applicable. It should be valid for not less than 180 days and it should be fully endorsed to the **Chief General Manager, BSRDCL**. Online B.G. Verification will be done.

18. a) Cost of BOQ and Bid Processing Fee (Column-5 & 6 of clause 8) is mandatory to be paid through online mode only (Internet Payment gateway (IPG), Challan). A scanned images of valid proof to be uploaded along with the tender documents.
b) "Bid along with necessary online payments must be submitted through e-procurement portal www.eproc2.bihar.gov.in before date and time specified in the N.I.T. The department does not take any responsibility for the delay/Non submission of Tender/Non Reconciliation of online payment caused due to non-availability of internet connection, Network, traffic/holidays or any other reason.
19. Bidders can access tender documents on the website and must fill them and submit the completed tender documents in electronic form on the website itself. Bidders/ Contractors shall upload scanned copies of all required papers and certificates as required in the eligibility criteria. All the uploaded documents shall have the signature of bidder or their authorized signatories. The scanned copies should be of the original papers and certificates.
20. Corrigendum/ Addendum, if any, will be published on the E-proc-2 website and BSRDCL Website only.
21. Bids from joint ventures are allowed as per the eligibility criteria and other instructions issued by Road Construction Department, Bihar.

22. In the unlikely event of the server for www.eproc2.bihar.gov.in being down for more than two consecutive hours (in the period from midnight to closing time for receipt of tenders) on the last date of receiving of bid, the last date of the same shall automatically be extended to next working day till the last receiving time stipulated in the original NIT.
 23. The bidders are requested to check their file size of uploaded documents at the time of submission & they should ensure that work file is uploaded. If they feel that the complete file is not uploaded then they should click on cancel & update the same before submission. The bidders should satisfy themselves of Download ability/visibility of the scanned & uploaded file by them.
 24. The bidders are directed to zip their files using WinZip or Win RAR software only. Other formats of zipping will not be accepted and will be rejected.
 25. The bidder must use MS Office-2007 or lower version.
 26. File size should be less than 50 Mb and should be in MS Word, MS Excel, PDF and JPEG formats.
 27. No claim shall be entertained on account of disruption of internet service being used by bidders. Bidders are advised to upload their bids well in advance to avoid last minute technical snags.
 28. As per clause No 3.3 of section –I (ITB) of the SBD and department letter no – 3987 (s) dated- 28.04.2012, tenderers will have to declare by affidavit that they have not been declared defaulter or blacklisted by any state Government/Central Government/Public undertaking. If such affidavit found to be false, their tender shall not be considered and further legal action shall be initiated.
 29. As per clause 4.8 of ITB of SBD it is mandatory for bidders to upload an affidavit to the effect that they are not ineligible to participate in the tender (Ref: RCD letter no- 3407 (s) dated- 18.03.2011.
 30. Deduction of Royalty from running bill vide letter No.3082 (E), dated 27.04.2018 of Engineer in Chief, RCD, Govt. of Bihar. Seigniorage & Other applicable taxes shall be deducted as per Govt. of Bihar norms from the running bills.
 31. Estimate cost/ECV may vary; Amount of EMD will be as per amount of BOQ.
 32. This is SBD based tender so all conditions of SBD shall be applicable. Before uploading tender, bidders are advised to go through the SBD uploaded with the tender document.
 33. During verification of EMD, if it is found false, the concerned Bidder would be blacklisted by the department.
 34. Proper affidavit regarding hire/lease/Owned to be procured of equipment must be uploaded.
 35. The interested contracting firms shall also have to comply the requirement of registration, if applicable as per office memorandum no. F.No.6/18/2019-PPD dated 23rd July, 2020 issued by Public Procurement Division, Deptt. Of Expenditure, Ministry of finance, Govt. of India, are only eligible.
