Information to the Bidder (Technical Evaluation)

Tender was invited through NIT PR No. -021940 (B&C) 2024-25 for Construction of ROB and its approaches in between Warsaliganj & Nawada Railway Station in lieu of LC No-33/B1 in Nawada District." through e-procurement on SBD Basis. The Technical Bid of the aforesaid Tender was opened on 09.04.2025 at 15:30 hours, at BSRDCL HQ through www.eproc2.bihar.gov.in in presence of BSRDCL Officials.

2. Five bidders have submitted their bids viz.(i) M/s JSP Projects Pvt. Ltd., (ii) M/s Baba HansConstruction Pvt. Ltd. (iii) M/s P&R Infraprojects Limited, (iv) M/s Tribeni Construction Limited and (v) M/s Fortune Group.

3. Out of Five Bidders, one Bidder M/s P&R Infraprojects Limited has declared non-responsive due to not qualifying in the following criteria:

(a) Bidder submitted BOQ which mentions Pile work of 880m, further RA Bill for the said work has also been enclosed which states that the executed RCC Pile work is 844.30m against the required quantity of RCC Pile work 845m.

(b) Experience of execution of RE wall quantity is certified by the Contractor instead of Principal Employer.

4. Another one Bidder M/s Fortune Group has also declared non-responsive due to following reason:

As per NIT, the original instrument i.e. EMD was to be submitted before opening of Technical Bid i.e. on 09.04.2025 by 12:30 PM. The document of M/s Fortune Group received through courier on 15.04.2025. Accordingly the document was delivered after opening of the Technical Bid which is not as per the requirement of NIT.

5. Remaining three bidders namely (i) M/s JSP Projects Pvt. Ltd., (ii) M/s Baba Hans Construction Pvt. Ltd. and (iii) M/s Tribeni Construction Limited have qualified all the criteria of qualifications, hence declared responsive in Technical Bid for consideration of their financial bid.
