Information to the Bidder (Technical Evaluation)

Tender was invited through NIT PR No. -20656 (B&C) 2024-25 for Construction of ROB with Limited Height Subway (LHSW) (Between Siwan-Pachrukhi Station) and Approach Road in lieu of crossing LC No 91 SPL on SH-89 (Babuniya-Siswan) Road in Siwan District" through e-procurement on SBD Basis. The Technical Bid of the aforesaid Tender was opened on 12.04.2025 at 15:30 hours, at BSRDCL HQ through www.eproc2.bihar.gov.in in the presence of BSRDCL Officials.

- 2. Three bidders have submitted their bids viz (i) M/s Adyaraj Developers Pvt. Ltd, (ii) M/s Brajendra Kumar Buiders Pvt. Ltd. and (iii) M/s JK-JM-JV.
- 3. Out of Three Bidders, one Bidder M/s Brajendra Kumar Buiders Pvt. Ltd. has submitted experience certificate mentioning 291.94 m Bridge Length against the requirement of a ROB/Major Bridge/Flyover of structural length not less than 385.50 m. Thus, Bidder M/s Brajendra Kumar Buiders Pvt. Ltd. doesn't fulfil all the requirement of qualification as required in SBD clause 4.5 A (c) of ITB.
- 4. Remaining two bidders namely (i) M/s Adyaraj Developers Pvt. Ltd. and (ii) M/s JK-JM-JV are qualifying all the criteria of qualifications. Hence, declared responsive in Technical Bid for consideration of their financial bid.
- 5. Accordingly, Bid Evaluation Committee has made following recommendations: -
