7. The interested consultancy firms shall also have to comply the requirement of registration, if applicable as per office memorandum no. F.No. 6/18/2019-PPD dated 23rd July, 2020 issued by

Public Procurement Division, Deptt. of Expenditure, Ministry of Finance, Govt. of India, are only eligible.

8. The Applicant shall furnish as part of its Proposal, a RFP Security in the favour of Chief General Manager, Bihar State Road Development Corporation Ltd. Patna for an amount of Rs. 5,00,000 (Five Lakhs Only) in the form of Bank Guarantee (as per the format specified in Appendix N of the RFP document) for a validity period of 180 days after the last date of submission of RFP. Bid Security in Original form will have to be deposited along with Hard Bound Copy of Technical Proposal in the office of Chief General Manager, Bihar State Road Development Corporation Ltd. Patna on or before 12:00 Hrs on date specified above and mentioned in Data Sheet, failing which the Proposal will be rejected.
9. E-tendering processing fee, which is Rs.-17,700.00 (Rupees Seventeen Thousand Seven Hundred only) shall be paid online to BELTRON at the time of uploading of RFP.
10. For participating in E-RFP process, the applicant shall have to get them registered to get user ID Password and digital Signature. This will enable them to access the website-www.eproc.bihar.gov.in and participate in e-tender.
