1. No retired Government official shall be eligible for engagement unless there is a gap of Fifteen (15) days between his/her retirement and engagement.
2. The term of appointment shall ordinarily be for an initial period not exceeding one year which will be extendable by another one year. Beyond two years after the age of superannuation, the term may be extended, provided it shall not be extended beyond attainment of 65 years of age.
3. A fixed monthly amount shall be paid by deducting basic pension from the last pay drawn at the time of retirement. There shall not be any annual increment/percentage increase during the contract period. No Dearness Allowance will be admissible during the period of contract. However, the candidate shall draw pension and the dearness relief on pension during the period of his/her engagement.
