Information to the Bidder (Technical Evaluation)

Tender was invited through NIT PR No. -009028(B&C) 2024-25 for "Construction of ROB and its approaches in between Dumraon and Baruna Railway Stations in lieu of LC No.- 67A on SH-79 (Dumraon - Bhojpur Road) in Buxar District" through e-procurement on SBD Basis. The Technical Bid of the aforesaid Tender was opened on 20.12.2024 at 15:30 hours, at BSRDCL HQ and Bid Evaluation Committee has made following recommendations:-

- 2. As per sl. no. 9 of NIT, the details of Technically Qualified/Disqualified Bidder have been published on the BSRDCL's website for the Standstill Period of 3 days on 08.01.2025 for receiving clarification on evaluated technical bids.
- 3. During Standstill Period, M/s Nalanda Engicon Pvt. Ltd., Patna has submitted clarification for withdrawal of MOU with M/s Lakshy Engitech LLP, Patna for Sub-Contracting 49% of work and to execute the project at 100% by M/s Nalanda Engicon Pvt. Ltd., Patna only and requested to consider their firm for Technical qualification.
- 4. Further, it has been found that the Bidder M/s Nalanda Engicon Pvt. Ltd., Patna has not submitted any experience certificate related to Similar Nature of work (i.e. executing construction of ROB) pursuant to Section G. Appendix to ITB (sl. no.- 4) and Clause 4.5A(b) of Bid Document (SBD), rather it has submitted experience certificate related to Major Bridge.
- 5. Accordingly, in continuation to recommendation of Bid Evaluation committee held on 24.12.2024, the Bid Evaluation committee has made following final recommendations:
 - i. Bidder namely M/s Nalanda Engicon Pvt. Ltd., Patna may be declared Technically Disqualified pursuant to Section G. Appendix to ITB (sl. no.- 4) and Clause 4.5A(b) of Bid Document (SBD).
 - ii. Remaining two Bidders namely M/s Baba Hans Construction Pvt. Ltd., Patna and M/s Niraj Cement Structurals Ltd., Mumbai may be declared Technically Qualified.
- 6. As per sl. no.- 9 of above NIT, the final recommendation of Bid Evaluation committee is hereby published for the **Standstill Period** of **3 days** for receiving clarification on evaluated Technical bids. If no clarification is sought within the stipulated time frame, Financial Bid of the Technically Qualified Bidder shall be opened on www.eproc2.bihar.gov.in upon getting approval of Tender Committee on the above recommendation.
