The Contractor (the successful Bidder) shall be responsible for the Design, Engineering, Procurement, Construction and Maintenance (for 10 years including DLP) of the project in terms of the Agreement to be signed between the Contractor and BSRDC Ltd. Further, the Contractor shall be responsible for remedying all defects & deficiencies and normal wear & tear expected in the project or any section thereof during the Defects Liability Period/Maintenance period in terms of the EPC contract to be executed in terms of the RFQ and RFP.
